Re-designation of the Saginaw Metropolitan Planning Organization by Michigan Governor

As of October 1, 2020, the Saginaw Metropolitan Area Transportation Study (SMATS) the Metropolitan Planning Organization (MPO) for the county of Saginaw has been re-designated by the Gretchen Whitmer, Governor of the State of Michigan. Since the re-designation the Saginaw MPO name has been changed to the Saginaw Area Transportation Agency (SATA).

Federal Requirements

The MPO is required by Federal law to prepare a Transportation Improvement Program (TIP) to indicate how the Metropolitan Transportation Plan (MTP) will be implemented. Preparation of the TIP is required by federal legislation known as Moving Ahead for Progress in the 21st Century (MAP-21) and by the Metropolitan Planning Regulations (23CFR 450.324) of the United States Department of Transportation (USDOT). The MPO's current TIP Transportation affects everyone and thus a safe, accessible, affordable, and reliable transportation system is vital to all users. Every urbanized area with a population of more than 50,000 must have a designated Metropolitan Planning Organization for transportation to qualify for federal highway or transit assistance. MPOs play a vital role in planning the local and regional transportation systems, conducting public outreach, preparing short- and long-term transportation plans, and helping to prioritize the spending of federal dollars. MPOs ensure that highway and transit projects which use federal funds are products of a credible planning process and meet local priorities. Since MPOs are made up of those agencies responsible for carrying out transportation programs in the region, the process (conducted in a cooperative, comprehensive, and continuous manner) puts all agencies into a partnership with one another to carry out the programs.

Map-21 Requirements

MAP-21 requires that MPOs to publish an annual listing of projects for which funds have been obligated in the preceding year as a record of project delivery and a progress report for public information and

disclosure. In addressing MAP-21 requirements, this report lists all transportation projects in the study area that were obligated during Fiscal Year 2020 (October 1, 2020 - September 30, 2021).
